#### Recipient-Distinguished Faculty Award for Scholarship

Stuart Allen (Ph.D., Organizational Leadership) is a Professor in the Department of Organizational Leadership at Robert Morris University. He also teaches research design on the Doctor of Science in Information Systems and Communications program. He is an active researcher, dissertation advisor, author, and editor in leadership, leadership and management education, workplace pluralism and diversity, teaching with technology, organizational design and development, and sustainability. Stuart is originally from South Africa, where he worked as an industrial psychologist, CEO, executive coach, consultant, and entrepreneur. One of his consistent areas of publishing examines the role of religion and spirituality in the lives of leaders. Stuart recently completed work as lead editor on a new book called *The Handbook of Teaching with Technology in Management, Leadership, and Business* which will be published by Edward Elgar in the Fall of 2020.
